Maestas Taekwon-do will pay the Apex entrance fee of all officials and competitors. All spectators, regardless of age, must pay a \$5.00 Apex Center entrance fee. The fee covers use of all facilities of the Apex Center (except for Ice). Wrist bands will be available for purchase during in. The Maestas School Challenge XVI consists of two competitions: a junior individual competition and adult individual competition.

1. Coaches will NOT be allowed.
2. Students from 10th Gup High White Belt to 6th Dan Black Belt are allowed to compete.
3. All competitors must wear headgear when sparring.
4. Officials must dress in blues per USTF Tournament Rules and Regulations Handbook.
5. Junior and Adults are competing in individual sparring, patterns and power breaking. However, a competitor may scratch in an event they do not wish to compete in.
6. Schools with 5 or more competitors (any combination of junior or adults) will earn points towards the overall school championship. Schools with less than 5 competitors may join together for the championship. The championship is based on a weighted scoring system where each first place earns 7 points, each second place earns 5 points and each third place earns 3 points. There is only one 3rd place per bracket.
7. This is a USTF sanctioned event and the USTF Tournament Rules and Regulations Handbook is the basis of the event.
