Sereff World Camp - 2026 - YMCA of the Rockies, Snow Mountain Ranch,

June 21st - 26th, 2026 - Submitted by Grand Master Sereff, USTF Test Director and USTF Administrator

Sereff Taekwon-Do is excited to welcome you and your family to the 2026 Sereff World Camp, a week of world class Taekwon-Do training in the breathtaking Rocky Mounts of Winter Park, Colorado. From Grand Lake to Snow Mountain Ranch, campers will experience a full week of challenging and inspiring training with some of the finest instructors in the world. The traditional waterfall and lake training sessions promise to be both unforgettable and invigorating.



Accommodations and meals: All campers are required to stay on campus. Each room will accommodate 4-5 campers in a single room. The bunks include linens, blankets, and towels. A three meal per day service is included. USTF Headquarters will handle room assignments; however, if you have a preferred roommate, please include your request in writing when submitting your registration forms.

Arrival and Check-In: Campers should arrive no earlier than 3:00 p.m. on Sunday, June 21. USTF HQ will check in the group at approximately 4:00 p.m. Please do not check in individually at the Lodge. Many campers will meet at Sereff Taekwon-Do in Broomfield, Colorado, to carpool to Snow Mountain Ranch around 1:00 p.m. that Sunday. We recommend flying into Denver on Saturday evening or early Sunday morning. Details on nearby hotel accommodations can be provided once your registration is received or you can search by Google for hotels near Broomfield. Dinner will be served at approximately 5:00 p.m., following room assignments. Additional information, including meeting locations will be sent about one month prior to camp. A packing list is included in the registration flyer.

Eligibility: Students under the age of 13 must include a written instructor recommendation with their registration form for review and approval.

**Training and Instruction:** Campers will train under the guidance of USTF Grand Masters, Senior Masters, International Instructors, and selected Junior Instructors from around the world, offering unparalleled opportunity to learn from the best Taekwon-Do black belts in the world.

Travel and Departure: Please send your travel plans to Sereff Taekwon-Do Headquarters no later than one month before camp. If you plan to carpool, arrive at Sereff Taekwon-Do by 1:00 p.m. on June 21. If you are flying home, schedule your departure after 5:00 p.m. on Friday, June 26, allowing sufficient time to arrive and check in at Denver International Airport at least two hours before your flight.

Non-refundable deposit: \$350, due by December 30, 2025

Remaining Balance: \$350, due by May 1, 2026



## **Grand Master Sereff - Teaching Through Changing Times**

In the Martial Arts Community, we have always experienced our share of ups and downs, especially when it comes to student attendance. It is important to remember that our leaders prepared us for these challenges. We teach whoever walks through the door, whether it is five students or twenty-five. Over the years, many of us have tried various class structures, beginner -only, adult-only, junior-only, and other specialty sessions. What works? Ultimately, it is any effort that continues the teachings of our USTF leader, Sr. Grand Master Charles E. Sereff. Sometimes, patience is all that is needed.

Students today may not progress with the same consistency or commitment that many of us experienced in earlier years.
