This tournament is officially sanctioned by the United States Taekwon-Do Federation and its rules and regulations. St Anthony's Tri Parish Catholic School Taekwon-Do cordially invites all USTF-affiliated schools and their students to participate. The event will feature competition in individual patterns, sparring and 3-person team breaking. Brackets will be determined on the day of the tournament and will be at the sole discretion of the chief bracket-tier.

The competition will be conducted in accordance with the rules established by the USTF. Participants in sparring events are required to wear protective gear: hand and foot pads, mouthpiece, Head gear, and a protective cup (for male competitors) All referees and judges must be certified by the USTF and comply with the official dress code set forth by the Federation. The event will begin with Black Belt patterns competition followed by color belts patterns.

This event is open to all color belts 10<sup>th</sup> gup white to 1<sup>st</sup> gup red and Black belts 1<sup>st</sup> Dan through 5<sup>th</sup> Dan. Competitors can sign up for each event they would like to participate in. Competitors in Breaking should have the team captain sign the team up on one entry form. Breaking teams may also register the day of the tournament.

**We encourage all students to pre-register by September 4<sup>th</sup>. We will accept registrations on the day of the event, but competitors must pay an additional \$10.00 fee for same day registration. One form for each competitor please.**

Divisions are Junior, 11-15. and Adult, 16 and older. Teams are 3 person teams and can consist of any combination of boys and girls. Or Color Belt and Black Belt. Competitors must be green stripe or above.

Breaks are as follows:

Junior- Downward strike with the knife hand or side fist

Adult – Outward strike with the knife hand

Any standing kick, modified side kick OK

Any standing kick, modified side kick OK

180 back kick, standing back for blue stripe and below

180 back kick, standing back kick for blue stripe and below

LIABILITY AND PHOTOGRAPH/VIDEO RELEASE AGREEMENT  
FOR SPORTING TOURNAMENT PARTICIPANTS

This Liability and Photograph/Video Release Agreement ("Agreement") is entered into by and between the undersigned Participant ("Participant") and St. Anthony's Tri-Parish School, St. Anthony's Tri parish school Taekwon-Do, the Tournament Promoters, The United States Taekwon-Do Federation, Inc., and the officers, employees, and agents (collectively, the "Released Parties").

1. ASSUMPTION OF RISK

Participant acknowledges and agrees that the sport of Taekwon-Do involves inherent risks of bodily injury, including, but not limited to, the risk of serious physical harm or death. Participant voluntarily assumes these risks and all other risks associated with participating in the sporting tournament (the "Tournament"), including but not limited to risks arising from: (a) Physical contact with other participants; (b) Use of equipment; (c) Venue conditions; (d) Travel to and from Tournament events; and (e) Any other activities related to the Tournament.

2. RELEASE OF LIABILITY

In consideration of being permitted to participate in the Tournament, Participant, for themselves and on behalf of their heirs, executors, administrators, and assigns, hereby releases, discharges, and covenants not to sue the Released Parties for any and all claims, demands, or causes of action that Participant may have or acquire against the Released Parties for personal injury, sickness, death, or property damage occurring during Participant's participation in the Tournament. This release does not apply to claims arising from the willful, wanton, or reckless misconduct of the Released Parties. Participant acknowledges that this release is intended to be as broad and inclusive as permitted by the laws of the State of Wyoming.

3. MEDICAL TREATMENT AUTHORIZATION:

In the event of injury or illness during the Tournament, the Releasers authorize the Releasees to secure necessary medical treatment, including but not limited to first aid, CPR, the use of ambulances, EMT assistance, and hospital care. The Releasers agree to be financially responsible for any costs incurred as a result of such treatment and agree to indemnify and hold harmless the Releasees from any claims arising from such medical treatment.

4. COMPLIANCE WITH RULES AND REGULATIONS:

The Releasers agree to comply with all rules, regulations, and instructions provided by the Releasees in connection with the Tournament. Failure to comply with such rules, regulations, or instructions may result in immediate dismissal from the Tournament without refund or recourse.

5. INDEMNIFICATION

Participant agrees to defend, indemnify, and hold harmless the Released Parties from and against any and all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including reasonable attorneys' fees, arising out of or connected with: (a)

Participant's participation in the Tournament; (b) Any breach of this Agreement by Participant; (c) Any negligent or wrongful act or omission of Participant during the Tournament; or (d) Any violation by Participant of any applicable laws, rules, or regulations. This indemnification obligation shall survive the termination or expiration of this Agreement.

6. PHOTOGRAPH AND VIDEO RELEASE

Participant hereby grants to the Released Parties the irrevocable right and permission to use, reproduce, publish, and display any photographs, videos, or other recordings taken of Participant during the Tournament (collectively, the "Media"). Participant waives any rights of privacy or compensation with respect to the use of the Media as specified in this Agreement.

7. GOVERNING LAW AND VENUE

This Agreement shall be governed by and construed in accordance with the laws of the State of Wyoming, without giving effect to any choice of law or conflict of law provisions. Any legal suit, action, or proceeding arising out of or relating to this Agreement shall be instituted exclusively in the federal courts of the United States or the courts of the State of Wyoming, in each case located in the City of Casper and County of Natrona. Participant waives any and all objections to the exercise of jurisdiction over Participant by such courts and to venue in such courts.

8. SEVERABILITY

If any provision or portion of this Agreement is held to be invalid, illegal, or unenforceable in any respect under any applicable law or rule in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other provision or any other jurisdiction, but

this Agreement shall be reformed, construed, and enforced in such jurisdiction as if such invalid, illegal, or unenforceable provision had never been contained herein.

9. ACKNOWLEDGMENT

Participant acknowledges that they have read this Agreement in its entirety, fully understand its terms, and voluntarily execute it. Participant further acknowledges that they have had the opportunity to consult with legal counsel of their choice regarding the terms and conditions of this Agreement.
